Community risk reduction. We had 10 public education events. 3 PR events. 3 inspections. 3 plan reviews. 5 open burning permits. Firefighters completed total of 284 hours of training.

Maintenance. Station #2 flooring project's done. B shift repainted two of the rooms out in the apparatus bay.

2005 apparatus is still out for refurbish. One of the brush trucks is out of service. One of the tankers is out of service for throttle issue.

Administration. Additional training for the ESO software system. Meetings with Work Comp provider.

Firefighters had two days of live fire training at South Platte's facility.

Captain Traub and Firefighter Shane Moore went to the Blue River Community College job fair.

Applications received. One qualified applicant was moved on in the process. Two more applicants scheduled for interviews Dec 6 & 7.

Chief reached out to 10 different fire academies throughout Missouri and Kansas on the Kansas side trying to get recruitment information out.
