Firefighters completed total of 142 hours of training.

Maintenance. Geothermal heating system at Station #3 issues not yet resolved.

Parts on order for oil leak and air leak in newest pumper.

Waiting for front end suspension warranty parts on squad.

Tanker currently functional but check engine light and ABS sensor comes on. Believed to be a throttle positioning sensor

Inflatable boat was repaired for the second time

One of the pump manifolds was repaired on one of the brush trucks

Station supplies have been received

Administration. February 5, hosted University of Missouri Fire Rescue Training Institute fire school web cast

A round of first interviews held the 14th, another round today. Final interviews completed end of last week for 4 individuals. 2 candidates scheduled for skills testing.
