Community risk reduction: 4 public education events. 7 PR events. 1 fire investigation conducted for the West Gail address. Total of 7 inspections, 2 plan reviews, and 10 permits.

220 hours of training completed for the month.

Maintenance. Pretty much unchanged from last month.

Fire alarm system at Station #2 inspected and batteries replaced.

Chief Cline spoke with the architect and contractor for the Station #3 project. And they are kind of reviewing the plans and looking to see what options there are with the geothermal system.

Apparatus. Parts on order for airbag leak.

Administration. Chief Cline had 1 application on hand and 13 applicants in varies phases of the application process.

Audit is complete. Michael Keenan will present at the next meeting.

Meeting set next week for Clay and Platte Counties and the City of Smithville between several different agencies to address communication issues with some incidents at Smithville Lake and how we can better coordinate the various agencies that are responding and fully utilize our radio system between the different entities.
