Dual-certified Technical Rescue/Wildland Firefighting Personal Protective Equipment

The Smithville Area Fire Protection District is seeking bids/proposals for the purchase of Dualcertified, to meet NFPA 1951 (Technical Rescue) and NFPA 1977 (Wildland Firefighting), personal protective equipment.

The following are minimum specifications and requirements for the equipment:

Units shall be new and include a manufacturer's warranty.

(24) Sets (jacket and pant) of Lion VersaProPlus dual-certified tech rescue/wildland firefighting personnel protective equipment.

Each set shall include;

Jacket – water repellant, Sigma shell in tan or khaki color. Mic tab, radio pocket, Scotchlite ventilated reflective triple-trim on chest, sleeve, and hem of jacket, flashlight tab and strap, PCA-reinforced elbows, take-up straps on the cuffs of the jacket, thermoplastic zipper, pockets with flap closure on the jacket. Jacket shall have 4-inch letters on the back of the coat which read "SAFD".

Pants - water repellant, Sigma shell in tan or khaki color. Large cargo pockets on the pants, belt loops and waistbelt, zippered legs for easy donning over boots, Scotchlite ventilated reflective triple-trim on side seam and cuff of pants, PCA-reinforced knees and pant cuffs, take-up straps on pant legs.

Bidder shall measure personnel for proper fit before placing order; <u>or</u>, Bidder shall provide demo/fitting gear of the same model for personnel to determine their proper size before placing order.

(24) pairs of Black Diamond Battle OPS w/ Composite Toe, 8", Waterproof, Side-zip

ALTERNATIVES FOR JACKET AND PANTS: SAFD realizes there are numerous manufacturers of dual-certified NFPA 1951 (Technical Rescue) and NFPA 1977 (Wildland Firefighting) compliant personal protective equipment. Bidders may provide bids for equipment which meets the same NFPA standards (1951 and 1977); and which has the same features as those listed

above. It is understood that fabric name/brand may be different. SAFD is not interested in one-piece 'cover-all/jumpsuit' style PPE.

ALTERNATIVES FOR BOOTS: Bidders may bid different options for similar boots. Boots do not meet to meet related requirements for wildland firefighting or tech rescue. Boots shall be black, zippered, with a composite toe, and at least 8 inches in height.

Bids shall include shipping/freight; deliverable to SAPD Station #2, 341 Park Dive, Smithville, MO 64089.
