Station #3. Estimate received to repair the floor heating system by replacing/installing water pump: Pump is about \$4,500; with installation about \$6,000. Parts are on order.

Pumper out for some warranty repairs should be back this week.

Update on the items that were up for auction:

2015 pickup sold fo \$16,600 and was picked up last Week.

Damaged boat sold for the minimum bid of \$10.

Tires taken off the squad sold for \$1,000.

2018 pickup currently listed with a minimum bid of \$20,000. Bidding closes at 5:00 on 3-27-25.
